I hereby enter a plea of “no contest” to the violation of _____ and waive my right to a jury trial. I request that the Court allow me to complete a Deferred Disposition sentence for this case. I understand that if I successfully complete the terms of the Deferred Disposition in a timely manner, my case will be dismissed. If I do not successfully complete the terms of the Deferred Disposition, I will be sent a notice to appear in court to show cause why I did not complete the terms of this deferral. If cause is not sufficient, I understand that the Deferred Disposition will be revoked, a judgment of guilt entered, and the conviction will be reported to the Department of Public Safety to be placed on my driving record.

I swear or affirm that the following statements are true:

- I am the charged with this violation and making this request voluntarily.
- I waive my right to a jury trial and waive the objection to any defect in the charging instrument, the filing of a sworn complaint and notice of a sworn complaint.
- I have not been on Deferred Disposition for dismissal of any offense within the past 12 month period nor am I currently on Deferred Disposition in the City of Chandler.
- I did not or do not hold a Commercial Driver’s License.
- I was not charged with exceeding the posted speed limit in excess of 25 miles per hour or driving 95 miles per hour or greater.
- I have not been charged with an offense that occurred within a Construction or Work Zone when workers were present.
- I understand that I may be placed on probation for a period of time not to exceed 180 days.
- I understand that failure to comply with the terms of my deferral by failure to pay assessed fees and costs or completion of any requirements imposed, will result in a mandatory court appearance.
- I was not charged with a violation involving a traffic accident.

I understand that the deferral period will not begin until the Judge grants it and the deferral payment has been made. I agree to the terms of this deferred disposition which are:

1. Payment must be made within **10** business days from when the court notifies me the deferral has been granted. You **cannot** pay online; but can pay by cash, check, money order or credit card; **and**
2. Possess and maintain a valid driver license or permit during the deferral period (send copy with this request); **and**

3. Notify the Court in writing of any change of name and/or address; **and**
4. Commit no moving traffic violation within the State of Texas; **and**
5. I agree to return the judgement of Deferred Disposition Affidavit after deferral period. I understand if it is **Not** returned in by the due date, it will be a conviction on my driving record (Affidavit **must** be notarized).
