- 1. Payment must be made within <u>10</u> business days from when the court notifies me the deferral has been granted. You cannot pay online; but can pay by cash, check, money order or credit card; **and**
- 2. Possess and maintain a valid driver license or permit during the deferral period (send copy with this request); and

- **3.** Complete a six (6) hour Driving Safety Course approved by the Texas Department of Licensing and Regulation and submit to the Court:
  - The original "Court" copy of the certification of completion
  - DPS Driving test at the DPS office

## By the end of the deferral period; and

- 4. Notify the Court in writing of any change of name and/or address; and
- 5. Commit no moving traffic violation within the State of Texas; and
- **6**. I agree to return the judgement of Deferred Disposition Affidavit after deferral period. I understand if it is **NOT** returned in by the **due date**, it will be a conviction on my driving record (affidavit **MUST** be notarized).
