

PUBLIC HEARING NOTICE
CITY OF CHANDLER
TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

The City of Chandler will hold a public hearing at 5:01 p.m. on December 19, 2022, at Chandler City Hall located at 811 Hwy. 31 East Chandler, Texas regarding the submission of application(s) to the Texas Department of Agriculture for upcoming Texas Community Development Block Grant Program (TxCDBG) grants. The purpose of this meeting is to allow citizens an opportunity to discuss the citizen participation plan, the development of local housing and community development needs, the amount of TxCDBG funding available, all eligible TxCDBG activities, and the use of past TxCDBG funds. The City encourages citizens to participate in the development of these TxCDBG application(s) and to make their views known at this public hearing. Citizens unable to attend this meeting may submit their views and proposals to Libby Fulgham, Mayor, at City Hall. Persons with disabilities that wish to attend this meeting should contact City Hall to arrange for assistance. Individuals who require auxiliary aids or services for this meeting should contact the City at least two days before the meeting so that appropriate arrangements can be made. Citizen Participation & Grievance Procedures Notice

The City of Chandler has adopted complaint and grievance procedures regarding its Texas Community Development Block Grant Programs (TxCDBG). Citizens may obtain a copy of these written procedures at City Hall located at 811 TX-31, Chandler, Texas between the hours of 8:00 a.m. and 4:00 p.m. Monday through Friday. Citizens may also request the procedures be mailed to them by calling City Hall at (903) 849-6853. These procedures outline the steps for a citizen to follow if s/he wishes to file a complaint or grievance about TxCDBG activities.

A person who has a complaint or grievance about any services or activities with respect to the TxCDBG project, may during regular business hours submit such complaint or grievance, in writing to the City at 811 TX-31, Chandler, Texas or may call (903) 849-6853. The City Attorney will make every effort to respond fully to such complaints within fifteen (15) working days where practicable.

Política de no discriminación por motivo de la discapacidad
